Township: No to Firearms Registration

On Monday May 8, 2017 at 5:30pm the Kayenta Township Commission held its regularly scheduled monthly meeting. Among the agenda items was resolution #KTCMY-30-17 "Opposing Proposed Navajo Nation Council Legislation No. 0114-17 Amending Title 17 of the Navajo Nation Code and Enacting the Navajo Nation Firearms Act". This legislation was drafted and put forth by Navajo Nation Council Delegate Davis Filfred of Aneth, UT.

The resolution was first presented to the Kayenta Township Commission at last month's regularly scheduled meeting on April 10, 2017 but was tabled because the Commission wanted community input on the matter. The Commission directed Kayenta Town Manager Gabriel Yazzie to hold a public meeting at the Kayenta Town Hall.

This public meeting was held at 10am on May 4, 2017 and conducted by Kayenta Town Manager Gabriel Yazzie. In attendance were community members of Kayenta, the surrounding area and other communities such as Kaibeto and Oljato.


Kayenta Township Commissioner Jarvis Williams, Jodonna Hall/Ward and Rodger Grey made it a priority to be at the meeting to hear the public input. Three Navajo Nation police officers were in attendance as well.

Commissioner Hall/Ward addressed the audience first at the meeting and informed the audience that this piece of proposed legislation by Davis Filfred is very important and affects each and every firearm owner on the Navajo Nation. "We want your input on this issue so we can make the right decision for this community." Stated Ms. Hall/Ward.

Every community member that was in attendance, with the exception of the three Navajo Nation police officers, were opposed to the proposed legislation and voiced their concerns quite openly and candidly. Many stated that as responsible firearm owners they had already followed the mandatory background check when purchasing a firearm and that forcing everyone on the Navajo Nation that owned a firearm(s) to register and be put in a database is not what needs to be done to combat crime on the Navajo Nation.

The Navajo Police officers in attendance justified their support of the legislation by stating that a firearms registry would help them trace a firearm(s) used in a crime to its owner much easier. This was their only justification in support of the proposed Navajo Nation legislation.

First of all I would like to say congratulations to the two newly appointed Township commissioners Jarvis Williams and George Sisco III. I'm definitely looking forward to working with these two leaders who have business experience, have worked on several boards and governmental agencies in and around the community of Kayenta.

This year (2017) the Kayenta Township Commission approved KTCF-10-17, which approved the Township Scholarship application policy and procedures. This is the first for the Kayenta Township and I definitely hope that this scholarship is able to help assist students who are going to college. Students are eligible to apply for this scholarship each semester, which gives students competing for this grant an opportunity to receive \$250.00 for part time students and up to \$500.00 for full time students.


We also have beautification grants which are offered to businesses and organizations in the community of Kayenta. These beautification grants are cost reimbursement

grants, which mean that the organization(s) and/or businesses that are awarded the grant can get reimbursed up to \$50,000.00 after the project is completed.

This is a huge benefit for organizations and businesses because they are able to install landscaping i.e. trees, shrubs, decorative gravel and fencing. This is a first on the Navajo Nation of its kind and we hope that one the organizations and/or businesses install the landscaping making their place of business more presentable and therefore making the community of Kayenta more attractive and welcoming to community members and tourist visiting this part of Arizona.

We are also working on a redesign and construction of the 3.4 mile bus route. If you're asking yourself where this road is, it is located south of the Kayenta Chapter house and it runs in the eastern direction towards the N.A.T.I.V.E. campus.

This road was originally funded by Navajo Department of Transportation (NDOT) back in 2010 and Township finally moved the project into construction in 2012. The road has been sitting idle for quite some




time now and we felt that it would be best that we complete this project out past the N.A.T.I.V.E. campus so the road does not deteriorate any more than it has already.

I'm in hopes that we are able to get sidewalks included with the cost of this project, so community members and students can use the sidewalk when they are out walking or exercising.

Another road project that we anticipate on getting completed this year is the road that leads to the ADOT yard. The Kayenta Township is in partnership with ADOT to do a 2 inch overlay of asphalt on this road in the coming months. ADOT plans on utilizing their man power to install the product and the Township will purchase material for the project.

We are currently heading into the summer months, which means the 4th of July activities will be ramping up soon in the coming weeks and our community will be the place to be for the 4th of July. This is a very busy time of the year for the Township staff as we try our very best to prepare the community for visitors and tourist. Linville Laundry Demo


The Linville Laundromat/RV Park business thrived from about 1970 thru 2003 according to sources close to the Linville couple, Mr. and Mrs. Rex & Josephine Seaton Linville. Eventually the business would expand to include a day care center, a video store, arcade and later an auto parts store which never took root and slowly dissolved.

The facility sat idle for some time attracting vandals and unwanted illegal activity at all hours of the night as reported by neighbors and passersby. Teenage curiosity with alcohol and drugs was also beginning to take root, concerning parents and prompting phone calls to the Kayenta Township offices. Transients were also reported to have moved onto the property for shelter from the frigid weather and a camp type setting evolved in one of the buildings.

After two failed arson attempts, the Kayenta Township Commission took action to remedy the situation by resolution to demolish the facilities at a cost of \$160,000.00. The local utility companies, i.e. NTUA, Frontier, ADOT and NNEPA were procured to identify any hazardous material and to decommission all overhead/underground utilities prior to any demolition activity.

Through the Request For Proposal (RFP) process, RFP #KY300-4-01-7021, Kayenta Laundromat Demolition Project was awarded to All Nations Environmental, LLC, a Navajo owned Business to undertake the demolition of facilities on the 1 acre site.

Notice to Proceed was issued on March 20, 2017 and demolition completed on May 26, 2017. The 1 acre site is now available for entrepreneurs interested in doing business within the Township of Kayenta, considered a prime location for any type of business.



Arrowhead Engineering to Design Kayenta Township School Bus Route

Arrowhead Engineering Inc, a firm owned by Kayenta native Merwin Yellowhair, was selected to re-design a road project that has been stalled for some time.

The road project referred to as the "3.4 Mile Bus Route" is a bus route that was identified in the Kayenta Township Comprehensive Plan (see attached exhibit 15) as one of the planned transportation and circulation routes that would serve as a school bus route and the main arterial for future commercial and residential development. A major concern this route would help alleviate is to relieve congestion for the Kayenta Unified School District (KUSD) buses and traffic from its main entrance located along US 163. The "3.4 Mile Bus Route" project aptly named will be a 3.4 miles long paved bus route divided into two phases, I & II, and will eventually connect Kayenta's main thoroughfares US Highways 160 and 163.

Arrowhead Engineering was one of the many engineering and/or architectural design firms selected through an on-call procurement process where selection is based on merit of qualifications rather than competitive bid. Therefore competitively sealed proposals were

used versus competitively sealed bidding. Master Agreements were executed with selected firms to be on-call for the next three years with an option for additional 1 year terms following.

Kayenta Township has on-going needs for architectural and engineering services. Rather than go through a separate and timely selection process each time the need for such services arises through a project-specific advertisement and selection process, the Township can quickly contract new work through service orders. It also saves administrative time and expense involved in frequent advertising and selection processes.

Under the first service order of the on-call contract, Arrowhead Engineering is tasked with designing phase I of the 3.4 Mile Bus Route which is approximately .7 miles and starts at the existing Highway 163 near the Kayenta Chapter House and ends at the N.A.T.I.V.E school building.

Construction is scheduled to start in August of 2017 and upon completion will allow the Kayenta Chapter, Eve's Place, Dine' Bii Association (home for disabled), and the Northeast Arizona Technological Institute of Vocational Education (N.A.T.I.V.E.) to have paved access to their sites.





In attendance at the public meeting was Kayenta community member Shonie De La Rosa who is an active member of the National Rifle Association and the Arizona Rifle and Pistol Association. Shonie has stated that he will fight this legislation to the very end and people need to be educated on this very important issue. "I completely oppose this legislation. In my opinion there are more important things to worry about than registering firearms. We all know that drugs and alcohol kill far more of our people than firearms do." He further stated that, "The majority of the crimes on the Navajo Nation are drug and alcohol related and that the Navajo Nation needs to address that issue first."

A key point that Shonie De La Rosa brought up at the public meeting was the NICS (The National Instant Criminal Background Check System). Excerpt from their web site: Mandated by the Brady Handgun Violence Prevention Act of 1993 and launched by the FBI on November 30, 1998, NICS is used by Federal Firearms Licensees (FFLs) to instantly determine whether a prospective buyer is eligible to buy firearms. Before ringing up the sale, cashiers call in a check to the FBI or to other designated agencies to ensure that each customer does not have a criminal record or isn't otherwise ineligible to make a purchase.

BE IT ENACTED:
 SECTION ONE. AUTHORITY
 A. The Law and Order Committee of the Navajo Nation Council reviews and makes recommendations to the Navajo Nation Council proposed amendments to the Navajo Nation Code and possess oversight authority over the Navajo Nation Division of Public Safety, 2 N.N.C. §§ 601 (B)(14) and 601 (C)(1) (2012).
 B. The Naabik'iyáti' Committee of the Navajo Nation Council reviews proposed legislation which requires final action by the Navajo Nation Council, 2 N.N.C. § 164 (A)(9).
 C. Enactments of positive law must be reviewed and approved by resolution by the Navajo Nation Council, 2 N.N.C. § 164(A).

SECTION TWO. FINDINGS
 A. In addressing the immediate and future needs, the Navajo Nation identified nine priorities for the Nation, with public safety listed as one of the priorities. Navajo Nation Three Branch Agreement, One Nation One Voice (July 20, 2015).

RESOLUTION OF THE KAYENTA TOWNSHIP COMMISSION
 Opposing Proposed Navajo Nation Council Legislation No. 0114-17 Amending Title 17 of the Navajo Nation Code and Enacting the Navajo Nation Firearms Act.

- The Kayenta Township Commission ("Commission") is a home-rule municipality of the Navajo Nation with the general authority and responsibility to govern for the welfare of the Kayenta Township ("Township") and its residents, including the enactment of such ordinances, rules and regulations as it deems in the best interest of the Township, see 2 N.N.C. §§ 4081-4086 (2005); and
- The Navajo Nation Council has granted the Township "home-rule" status under the governance of the Commission pursuant to Resolution CNY-42-03 (July 29, 2003) (codified at 2 N.N.C. §§ 4081-4086 (2005)), and the Navajo Nation Supreme Court has recognized the comprehensive authority of the Commission in *Kayenta Township Commission v. Ward*, No. SC-CV-29-07 (Sup. Ct. Feb. 25, 2011); and
- On March 24, 2017, the Honorable Council Delegate Davis Filfred introduced Legislation No. 0114-17 to amend Title 17 of the Navajo Nation Code and to enact the Navajo Nation Firearms Act; and
- The Town Manager and the Commission have reviewed this Legislation and have the following concerns:
 - Currently there is a lack of enforcement and cooperation between the Navajo Nation Judicial Branch and the Navajo Nation Police Department;
 - The Navajo Nation currently lacks the manpower to enforce such legislation;
 - Funds are not available for a national gun registry that would have to be maintained at the local, state and federal level to be accurate;
 - There are a myriad of privacy concerns and access to information would have to be strictly controlled to prohibit tampering or abuse of the information;
 - Many gun owners may ignore the registry or provide misleading information, or information may be entered into the registry in a misleading or inaccurate manner;
 - A registry would document weapons that legal firearms owners possess, but would do little, if anything, to control the flow of stolen weapons, illegal weapons or weapons manufactured without serial numbers so as to make them untraceable; and
- For such reasons enumerated at Recital Paragraphs 4(a) - (f), above, the Town Manager recommends that the Commission oppose such proposed Legislation; and
- The Commission has heard the report and recommendation of the Town Manager and, with all due respect for the Honorable Delegate Filfred, agrees that the Commission should oppose proposed Legislation No. 0114-17, for the reasons stated above, and the Town Manager should be authorized to take any further reasonable actions consistent with this resolution, including posting comments with the Navajo Nation Council Office of Legislative Services.


Shonie stated that local, state, county and federal agencies contribute criminal records to this NICS database and that the Navajo Nation does not contribute to the NICS database. Therefore, anyone on the Navajo Nation convicted of a crime(s) such as domestic violence, drugs, etc. that would by federal law make an individual prohibited to possess firearms could easily purchase a firearm(s) without their Navajo Nation criminal record showing up on the mandatory NICS background check. "If the Navajo Nation would contribute these criminal records to the federal

database, it would make a much better impact than the proposed firearms registration Filfred Davis has proposed to the Navajo Nation." Said Shonie.

Kayenta Town Manager Gabriel Yazzie stated, "This was a very good meeting and we received a lot of good feedback from the community about this issue. I will take the input from this public meeting to redraft the Kayenta Township resolution Opposing Navajo Nation Legislation No. 0114-17 and present it to the commission at our next meeting."

On May 8, 2017 the redrafted resolution was presented to the Kayenta Township Commission at their regular scheduled monthly meeting. Kayenta Township resolution #KTCMY-30-17 passed that evening with a vote of 3 in favor, 0 opposed and 0 abstained.

"This is the first step in fighting this very important issue. Now that the Kayenta Township has passed this resolution opposing Filfred's proposed legislation, everyone on the Navajo Nation needs to encourage their community leaders to do the same and pass resolutions in their chapters opposing this legislation." Said Shonie.

NGS Should Continue Operations

Speaker Lorenzo Bates recently introduced Legislation 0194-17, which aims to keep the operations of the Navajo Generating Station (NGS) continuing until 2054. Any continued operations after 2019 is considered a monumental challenge but for many the continued operations of NGS is a necessity. As an elected leader for the community of Kayenta the continued operations of NGS is a priority for me. The Kayenta Mine is located 30 miles from the town of Kayenta and is the only customer for the Navajo Generating Station. It sustains over 400 good paying jobs and provides over \$118 million to the region and the state. Additionally, the Kayenta Mine contributes \$400,000 annually in scholarships and supplies numerous community benefits to the Navajo people such as coal to heat homes, potable water and maintenance of 173 miles of roads in and around the mine lease area.

The Navajo Nation Council now has the opportunity to make the right decision for the Navajo Nation with the approval of Legislation 0194-17. It cannot be stressed enough that the economic impact of the closure of NGS is enormous for all those in the Navajo Nation, Hopi Tribe and the entire state of Arizona. The Hopi Tribe could lose 85% of its operating budget and the Navajo Nation would be out of 22% of its general revenue.

Should we be concerned that a billion dollar organization seemingly decided on a whim to close up shop and leave? YES, we should be very concerned! For this billion dollar organization, the movement to close NGS is just a small part of the overall plan to move towards an historically unstable energy resource, natural gas. For many years, utility customers could rely on fair utility rates because coal energy offered stability and low prices. For our region, coal provided much needed employment and royalties to the Navajo Nation and Hopi Tribe.

This move by the owners of NGS is concerning because while everyone was under the assumption that the 2013 approved lease was ready for signature by the Dept. of Interior. This organization decided in Dec. 2016 to notify the Navajo Nation that the partners had yet to sign and they had six months to modify the lease to keep NGS operating. Why wait 4 years to deliver that information? Those new developments sent a message that the owners of NGS wanted to end their relationship with a region of the state that has provided a stable energy resource and a plethora of eligible workers. They seem oblivious to that fact that their decision would have a detrimental impact on the people of this region should NGS close its doors. They claim that it has become uneconomical and not profitable. By the looks of it, their \$2.7 billion passive attitude seems to imply that they want to further destabilize the utility rates in the state of Arizona by investing in a product that has been historically erratic. It doesn't make sense.

In the sports world, a coach values consistency because the team can depend on that athlete or team to perform at a certain level in each contest. Inconsistency creates more challenges for the team and the coach. So here is my analogy of this issue to help me better understand what is going on. There is an energy team made up of coal, natural gas, wind, nuclear, solar power and hydropower. To this point, the energy team has been doing okay however in the last few years the energy team has taken on new members. Wind, solar and natural gas were added because the athletic director said so. We aren't clear why that was done since they haven't shown to be valuable contributors in the past. So some years pass and the new additions received some additional help to get better however coal, hydro and nuclear are still the consistent, reliable team members. After a few years, team members; solar, wind and natural gas get better but still not consistent contributors.

The parents and family members of wind, solar and natural gas complain to the athletic director for more playing time. So the coach makes the decision to bench coal to give the new team members some playing time. For a few games, natural gas shows some improvement but still not consistent while wind and solar still struggle. A new coach arrives and decides that consistency is best move to bring the team back to their former success.

In the end, championship teams are made with consistent players that contribute valuable minutes to the team. Not that wind, solar and natural gas are bad players they are just inconsistent and will always need valuable contributions of coal, hydro and nuclear. Benching or cutting your most consistent players don't produce champions. Recently, the coal miners of Kayenta Mine decided to let their voice be heard and attended the Bureau of Reclamation's Listening Sessions in Phoenix, Page, Kykotsmovi and Window Rock, AZ. They talked with an honesty and candor that captured the intent of the of their eagerness to keep their livelihoods. It was truthful and emotional to say the least. Coal miners are valuable contributors to their families, to the Navajo Nation and to the State of Arizona. We should not forget that they are the hard working individuals that only want to provide the valuable opportunities for their families that coal mining offers. Their jobs helped raise children that are now doctors, nurses, paramedics, coaches, teachers and other valuable contributors to society.

Their statements reminded me of a difficult period in my community. I had arrived back in my hometown following the closure of Black Mesa Mine as a high school teacher. This was the sister mine to Kayenta Mine on Black Mesa that transported coal using a slurry to the Mojave Generating Station for a number of years and closed. I could see the impact on the students with their struggles in the classroom. For some students it was a difficulty in comprehension or attentiveness and for others it was a disconnect that was hard to recognize. Whether it was due to the lack of sleep, disinterest or an increased need to fill a void spurred by a single parent household, the students seemed to have been impacted in some way by the closure of the mine. Those challenges brought up the struggles at home, a result of single parent homes as the breadwinners had to find work away from their families. It was certainly an uncomfortable topic to discuss however it was an indication of the many workers that had lost their jobs at the mine. The jobs that once provided security and kept the family unit together was now lost.

For the Navajo Nation, the closure of Black Mesa Mine meant a loss of significant revenue and caused a huge adjustment in their government budget to serve the Navajo people. For the Hopi Tribe it was loss of over 50% of annual revenue to the tribe, which resulted in a significant blow to their daily operations and a decrease in services to their tribal members.

Looking back in remembrance of the hardships that the closure of the mine created I am very confident that our elected leaders will make the right decision and vote to keep the Navajo Generating Station in operation. I believe they will take into account the abrupt decision by the owners of NGS to close the plant leaving the Navajo Nation and its people in a bad position. Certainly, not the good neighbor relationship that we had thought we had built over the last 40 years. The decision by the Navajo Nation Council regarding the continuation of NGS will be made before the end of June. If there was a time to contact your leadership and discuss the importance of continuing the operations of NGS that time is now! There is another generation of young miners that are eager to work and provide for their families. For the Navajo Nation government the continuation of NGS is an opportunity to continue the valuable services for the Navajo people and to plan the next economic venture that will bring more jobs and revenue.






