On May 14, 2024, a judgment was entered in Case No. KY-CV-026-2020 (CV) against the Defendants pursuant to the Navajo Nation Forcible Entry and Detainer Act, 16 N.N.C. § 1801 *et seq.*, for restitution of a business site located at Highway 160, Milepost 394 in Kayenta Township, Navajo County, Arizona, Navajo Nation, identifiable by signage for “Chief Propane,” “Royal Chief Towing,” or similar (the “Premises”). Restitution of the Premises is to the Plaintiff Kayenta Township Commission on its own behalf and on behalf of the Kayenta Township (“Commission” or “Plaintiff”).

YOU ARE HEREBY COMMANDED pursuant to 16 N.N.C. § 1806(A) to immediately:

A. Remove from the Premises the Defendants Royal N. Churchill d.b.a. Chief Propane, Inc., Royal Chief Towing LLC, and Chief Propane & Accessories Inc., and their principals, owners, employees, and agents (collectively the “Defendants”), and to use such force as is necessary to effect removal of the Defendants if the Defendants resist.

B. Place the Commission in possession of the Premises.
